To apply for a new membership or to renew membership in the Edgewater Marina Boat Club, please follow the instructions below:

1. For renewal membership, please enclose a check **payable to EMBC** for the amount of the dues. Date the check as of the date you sign the application.
2. For new membership, you must be proposed by and have the signature on the application form of a current member in good standing. If you do not know anyone to propose you, contact the Membership Chairperson for instructions.
3. Give the completed application to an officer or to the member that is proposing your membership for forwarding to the Membership Committee. You will find this application on the back side of this page.

TYPES OF MEMBERSHIP

1. Regular—Regular membership can be granted to a person who owns a boat and docks at Edgewater Marina. Regular membership can also be granted to a past regular member of the CLUB in good standing who owns a boat but docks elsewhere. Regular members in good standing shall have all rights and privileges of the Club. Regular membership shall terminate May 31 of the current membership year.
2. Family—Family membership can be granted to a person who is a spouse, significant other, child or sibling eighteen years of age or older, of a regular member in good standing. Family members in good standing shall have all rights and privileges of the CLUB. Family membership shall terminate May 31 of the current membership year.
3. Associate—Associate membership can be granted to a person who does not own a boat but is associated with a regular member in good standing. Associate members in good standing shall have limited privileges of the CLUB, except those of holding office, voting at meetings or of holding any right, title, or interest in the property or assets of the CLUB. Associate membership shall terminate May 31 of the current membership year.
4. Life—Life membership—Regular or family members in good standing with 10 years or more in the CLUB, upon reaching the age of 62, shall be eligible for a life membership. A life member shall have all rights as that of a regular member. Life membership shall terminate May 31 of the current membership year

Applications are reviewed by the Membership Committee and forwarded to the Board for consideration. At the next monthly regular meeting, the Executive Board and general membership will determine the admission or exclusion of the applicant. The applicant must be present and introduced at the meeting in which they will be voted on. An associate or family member applicant must be accompanied by their endorsee.

All applications shall be accompanied by the full amount due and payable upon acceptance of the general membership.
